Dear Sir/Madam,

1. You are invited to submit your priced bid for the supply of the following items;

- i) Supply of furniture for canteen**

2. The bidder(s) may quote for any or all items under this invitation. Each item shall be evaluated and contract awarded separately to the firm(s) offering the lowest evaluated price for each item.
3. The bidder(s) shall submit one original of the priced quotation with the Form of Bid and clearly marked **ORIGINAL**. In addition, the bidder(s) should also submit one copy marked as **COPY**. The quotation including all documents in the attached format should be sealed in an envelope as required by PRR 2009 clause 5.1.7.2 and addressed to and delivered at the following address:

4. The deadline for receipt of your quotation(s) by the purchaser at the indicated address is **2nd November 2016 before 2:00 pm and will be opened on the same day at 2.30 pm.**
5. The bid shall be accompanied by a bid security of 2% of the total quoted amount in the form of warrant, demand draft or unconditional Bank Guarantee valid till 60 days, addressed to the Chief Executive Officer. Any bid not accompanied by bid security shall be treated as nonresponsive. The bid security of the unsuccessful bidders shall be returned within fifteen (15) working days after award of contract to the successful bidder. The bid security of the successful bidder shall be returned

immediately after the submission of performance security and signing of contract agreement by the successful bidder.

6. The quotation should be submitted as per the following instructions and in accordance with the attached Contract. The attached Terms and Conditions of Supply is an integral part of the Contract.

a) PRICE: all prices shall be quoted in Ngultrum. The quoted price shall be inclusive of all related costs including taxes, duties and other levies to the final place of delivery.

b) EVALUATION OF QUOTATION: offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their quoted prices and the firm's ability to deliver the goods. In evaluating the quotations, the purchaser will determine for each quotation the evaluated price by adjusting the priced quotation by making any correction for any arithmetical errors as follows;

(i) where there is a discrepancy between amounts in figures and in words, the amount in words will govern;

(ii) where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted shall govern unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted shall govern, and the unit rate shall be corrected.

(iii) if the supplier refuses to accept the correction, this quotation will be rejected and the bid security shall be forfeited.

c) AWARD OF PURCHASE ORDER: the award will be made to the bidder who is offering the lowest evaluated price that meets the specifications. The successful bidder will sign a contract as per attached form of contract and terms and conditions of supply.

d) VALIDITY OF THE OFFERS: your quotation(s) shall be valid for a period of **2 months** from the deadline for receipt of quotation(s).

 8. Depending on the final requirement, the purchaser may increase or decrease the quantities.
 9. The quotation(s) will be opened in the presence of bidders or their representatives who choose to attend at the specified venue and time.
 10. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
 11. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
 12. A minimum warranty period of six months shall be applicable to the supplied goods from the day the goods are received by the procuring agency.
 13. The payment will be made upon submitting the bill/invoice after the final delivery of goods to Thimphu TechPark Ltd. at its Office in Babesa, Thimphu.

Technical Specification of the Goods Required

The goods should meet the following minimum technical specifications:

1. Technical specification for jabla



Jabla is a simple dewan with back support as shown in the picture above. Dimensions: Length=60 inches; Width=20 inches; and height = 16 inches plus minimum 20 inches for back support. It should be supplied with cushion. The finishing and quality should match the picture shown above.

2. Technical specification for dewan

High quality dewan with good finishing, having the following dimensions: Length=60 inches; Width=18 inches; and height = 16 inches. It should be supplied with cushion.

3. Technical specification for centre tables



The centre table design can be a simple one similar to the picture above. Unlike in the picture, the wavy lines below the table top can be made straight. However, it should be strong and the finishing should be of high quality.

Dimensions: Length=48 inches; Width=24 inches; and height = 20 inches.
Table should have necessary lacquer or melamine paint finish on the top.

4. Technical specification for cafeteria chairs



The above cafeteria chair, known as “Comfortable Cafeteria Chair” as shown in the picture above is available from vendors in India (<http://www.indiamart.com/proddetail/cafeteria-chair-8310347862.html>) or (<http://www.indiamart.com/sai-enterprises-new-delhi/cafeteria-chair.html#comfortable-cafeteria-chair>). Our preferred chair is the one shown above because we already have some chairs in our cafeteria of the same design and make.

However, in case this is not available, you may quote for other kinds of cafeteria chairs that have some similarities with the above chair. You are required to submit pictures and technical specifications of the chairs you have quoted for.

The Supplier is required to mention make / model (as applicable) of the goods to be supplied and must attach the appropriate original printed literature / brochures for the various items listed.

Documents required to be submitted as part of the Quotation

The original and *copy (ies)* of quotation submitted by the supplier shall comprise the following:

- (a) A duly completed and signed priced quotation as per the Schedule of Items and the Priced Quotation.
- (b) A valid Trade License;
- (c) A valid Tax Clearance Certificate;
- (d) The required bid security;
- (e) Technical Specification of the Goods to be supplied; and
- (f) Any other requirements specified in this document

Terms and Conditions for the Supply of Goods and Payment.

The Terms and Conditions hereinafter may only be varied with the written agreement of the Purchaser and no terms and conditions put forward at any time by the Supplier shall form any part of the Contract.

1. The Supplier shall be required to submit a performance security of **10%** of the quoted price in the form of cash warrant, demand draft or unconditional Bank Guarantee issued by a financial institution located in Bhutan, which shall be furnished upon signing the contract. Performance security shall be valid till the end of warranty period and will be returned after the end of warranty period.
2. The supply of the goods shall be completed within **30 days** from the date of issue of the Purchase Order, or the signing of the contract (if applicable);
3. Payment of the Invoice shall be arranged by the Purchaser, within fifteen (15) days upon submission of original Invoice and TPN number, against the actual supplied quantities of goods as listed in the Purchase Order.
4. The quoted price shall include all taxes, duties, insurance and any other costs involved and nothing extra shall be paid.
5. Any goods found defective during the warranty period shall be replaced/repaired by the supplier at his cost. If the supplier fails to rectify and or replace the defective goods, the purchaser shall do it at the cost of the supplier.
6. The supplier shall pay liquidated damages at the rate of **0.1% per day** for each day of delay to a maximum of **10%** of the quoted price.
7. The Purchaser may, by written notice, terminate the Purchase Order (or Contract if applicable) in whole or in part at any time for its convenience:

-
- a. if the Supplier fails to perform any other Terms and conditions specified with the Purchase Order, or exceeds the maximum amount of liquidated damages.
 - b. if the Supplier fails to perform any other obligation(s) under the Purchase Order, or
 - c. if the Supplier does not take any remedial action within a period of (7) seven calendar days after receipt of a notice of default from the Purchaser specifying the nature of the default(s), or
 - d. if the Supplier, in the judgment of the Purchaser, has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this Purchase Order; and
8. The Supplier shall provide the warranty, as stipulated in the Quotation document, for the goods to be supplied and confirm that if any faults are detected within the warranty period in the supplied/installed goods, the Supplier shall be bound to rectify the fault or replace the goods as the case may be. The security deposit shall be used to cover the cost of supplies not delivered or defective items not replaced or rectified.
 9. The purchaser may procure any of the items from the open market in case the supplier fails to supply the goods within the stipulated time and realise the difference amount between the quoted price & market price from the security deposit.

Contract Agreement

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall constitute the Contract between the Purchaser and the Supplier, and each shall be read and construed as an integral part of the Contract, viz.:
 - (a) This Contract Agreement;
 - (b) Terms and Conditions;
 - (c) Technical Requirements (including Schedule of Supply and Technical Specifications);
 - (e) The Supplier’s Bid and original Price Schedules;
 - (f) The Purchaser’s Notification of Award of Contract;
 - (g) The form of Performance Security;
 - (h) The form of Bank Guarantee for Advance Payment; if applicable
 - (i) *[insert here any other document(s) forming part of the Contract]*
3. This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.

4. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

5. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Related Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of Bhutan on the day, month and year indicated above.
